In preparation for the 89th South Eastern Regional Conference, I attended the first -time virtual attendees training held on April 6 at 6:00 p.m. on Zoom. Ugo would be the platform that would be used to conduct the 89th South Eastern Regional Conference. A review of Protocol for the Virtual Conference was given by Soror Azande Williams. Each registered participant was asked to log in fifteen minutes before the sessions started. A navigational video was made available so that you could practice before the conference started. The SERC started with a Tour of the States, Alabama, Tennessee, and Mississippi. Great emphasis was put on the HBCU's, historical places in each state and greetings form local officials.

On April 6, 1921 Pi Chapter at Fisk University was chartered. This was also the 100th Anniversary of the South Eastern Region.

The Regional Director's Chat hosted by Soror Erin Pickens included Regional Directors Mary B. Connor, Velma Lois Jones, Nancy Sewell, Adrienne P.K. Washington, Ida K. Martin, Vanessa Rogers Long, Juanita Sims Doty, Cynthia Finch, Mitzi Dease Paige and Jo Celeste Pettway. Each and one explained that they had worked on other Soror's campaign and was encouraged to run for Regional Director, some by Soror Matilda Grays. Other former Regional Directors spoke about the reasons they ran for the office of Regional Director. My takeaway was that:

1) you must know your documents 2) you must have the time to run for office 3) Take courses first 4) participate on committees 5) work with your chapter 6) Study and be familiar with our Constitution and Bylaws, Manual of Standard Procedure 7) Look at your personal obligations: job, family and your community activity 8) Organizational skills are paramount and lastly 9) Are you financially able to participate and run for office.

Workshop 05: Exemplifying Excellence Through Sustainable Service - Through the Year (2020) as we struggle...

Ashley Tarrant (South Eastern Region Representative to International Programs) of Beta Nu Omega Chapter hosted this workshop. This workshop focused on the **Five Targets** and emphasized the outstanding work of South Eastern Chapters that implemented Innovative Excellence: The Push up Challenge (Beta Delta Omega Chapter), National Health Week (Phi Lambda Omega Chapter), Senior Salute(Beta Nu Omega Chapter) and Financial Freedom and Empowerment Webinar(Eta Xi Omega Chapter).

South Eastern posted 17,452 program reports for 2020. <u>Under Target 1: HBCU for Life</u> Alpha Kappa Alpha Sorority, Inc. raised 1 million dollars three years in a row. Signature program #CAPS received 2,293 reports from 632 chapters. Exceeded the goal of 5,715 students to

16,988. <u>Target 2: Women's Healthcare and Wellness</u>, 1.5 million women were reached with 1.4 million volunteer hours achieved. 1,424 mammograms were provided and 10% were referred for further testing. Walking with the Supreme note that you can send your steps to the Chapter chair for Target 2. The SERC is lacking in participation from chapters.
